

## Privacy Policy

**Introduction:** The CSE Corporation ("Company" or "We") respect your privacy and are committed to protecting it through our compliance with this policy. This policy ("Policy") describes the types of information we may collect from you or that you may provide when you visit the website [www.csecorporation.com](http://www.csecorporation.com) (collectively our "Website") and our practices for collecting, using, storing, and disclosing that information.

By accessing or using this Website, you agree to Policy. This policy may change from time to time. Your continued use of this Website after we make changes is deemed to be acceptance of those changes, so please check the Policy periodically for updates. If you do not agree with our policies and practices, you must exit the Website.

**Information Collection:** This Policy applies to information we collect to provide our services, including information obtained or provided:

- directly from browsing or interacting with our Website;
- in email, text, and other electronic messages between you and the Company;
- through mobile and/or desktop applications available from the Company;
- upon submission by you to the Company; or
- created when you visit our Website, such as device information and communications data.

The Policy does not apply to information collected by the Company offline or through any other means, including on any other website operated by Company or any third party (including our affiliates and subsidiaries).

Our Website is not intended for children under 13 years of age and we do not knowingly collect personal information from children under 13. By continuing to use this Website, you confirm that you are at least 13 years of age. If we learn we have collected or received personal

**Use of Information We Collect:** We use the information we collect for the following purposes:

- Providing services and features, including providing product and technical information;
- Providing customer support, including directing any questions or requests you may have to the appropriate employee of the Company;
- Communicating with you about our services, news, updates, and events.
- To provide you with information that you request from us;
- To notify you about changes to our Website or any properties or services we offer or provide through it;
- To allow you to participate in interactive features on our Website;
- In any other way we may describe when you provide the information; and/or
- For any other purpose with your consent.

**Cookies and Data Collection Technologies:** As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website; and/or
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

We also may use these technologies to collect information about your online activities over time and across third-party websites or other online services (“Behavioral Tracking”).

Additional information we collect automatically includes statistical data, which helps us to improve our Website and to deliver a better and more personalized service, including by enabling us to:

- estimate our audience size and usage patterns; and

- recognize you when you return to our Website.

**Disclosure and Sharing of Your Information:** We may disclose aggregated information about our users, without restriction. In addition, We may disclose information that we collect or you provide as described in this Policy:

- to our subsidiaries and affiliates, including Biomarine, Inc.;
- to contractors, service providers, and other third parties we use to support the Company;
- to a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of the Company's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which information held by the Company about our Website users is among the assets transferred;
- to fulfill the purpose for which you provide the information;
- to the general public, when you submit content to a public forum such as blogs, social media, and other features of our Website;
- for any other purpose disclosed by us when you provide the information; and/or
- with your consent.

We may also disclose your personal information:

- to comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- if we believe disclosure is necessary or appropriate to protect the rights, property, or safety of the Company, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

**Where We Store Your Information:** Some companies that provide services to us run their services from outside the USA. We only let that happen if we are satisfied with their levels of security. Keep in mind that when you give us personal information it could be being transferred, stored or processed in a location outside the USA.

**Data Retention and Erasure:** We generally retain your personal information for as long as is necessary for the uses described in this Policy and to comply with our legal obligations. In certain jurisdictions, you can request to have all your personal information deleted.

**Choices About How We Use and Disclose Your Information:** We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information.

- **Tracking Technologies.** You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. If you disable or refuse cookies, please note that some parts of this site may then be inaccessible or not function properly.
- **Promotional Offers from the Company.** If you do not wish to have your contact information used by the Company to promote our own properties and services, you can opt-out by checking the relevant box located on the form on which we collect your data or at any other time by sending us an email stating your request to [privacy@CSECorporation.com](mailto:privacy@CSECorporation.com). This opt out does not apply to information provided to the Company as a result of other transactions.

**Your California Privacy Rights:** California Civil Code Section § 1798.83 permits users of our Website that are California residents to request certain information regarding our disclosure of personal information to third parties for their direct marketing purposes.

Further, effective January 1, 2020, the California Consumer Privacy Act (CCPA) allows California residents to request access to the personal information that the business has collected about the consumer.
